#### Scope

This Policy applies to Cognizant associates, vendors, and visitors working out of Cognizant facilities.

The Global Environment Health and Safety (EHS) Center of Excellence team will evaluate EHS performance by monitoring ongoing performance results outlined in the guideline for EHS objectives and targets and through periodic management reviews with key business leadership, including the Chief Executive Officer, Chief Financial Officer and Chief Corporate Affairs Officer.
- Adopting our own standards where laws and regulations do not provide adequate controls.
- Operating our facilities and continuing conservation efforts to reduce our environmental footprint and adhere to our environmental (energy, water, and climate change) policies.
- Encouraging our contractors, vendors, suppliers and partners to adopt EHS best practices.
- Communicating EHS programs to Cognizant associates and encouraging them to report any environmental, health or safety concerns.

We are committed to achieving Net Zero GHG emissions and responsible management of natural resource consumption. Our Associates can support this commitment across our workspaces by:

- Focusing on energy efficiency management efforts.
- Reducing unnecessary water consumption and waste generation
- Encouraging your teams and new Associates to read this and related policies.

#### Disciplinary consequences
